## A 008. VILNIUS AIRPORT CHARGES

### Replace AIC A 010/2017

Revised Vilnius airport charges as applicable from the 1st of April 2018 are given below.

Types of charges, rates:

1. Departing passenger charge:
  - 1.1 transfer passenger – 1,57 Eur
  - 1.2 all others – 8,03 Eur

The departing passenger charge shall not be applied for serving a direct transit passenger and a child of up to 2 years of age.

2. Aircraft landing charge:
  - 2.1 per each ton of aircraft when the MTOM is 2 tons or over – 7,57 Eur
  - 2.2 when the MTOM is less than 2 tons – 4,03 Eur

Users whose aircraft depart from the Airport but cannot or are not allowed to continue their flight due to technical failures or meteorological conditions, are exempted from the aircraft landing charge.

Users whose aircraft land at the Airport as an alternate airport, shall pay 50% (fifty percent) of landing charge for landing services.

3. Parking charge:
  - 3.1 when the MTOM is less than 2 tons – 15,87 Eur
  - 3.2 when the MTOM is less than 2 tons – 15,87 Eur

The aircraft parking charge shall not be applied in the following cases:

- Aircraft stays less than 3 hours in the Airport;
- When User's aircraft carrying cargo by charter flights stays in the Airport for less than 6 (six) hours and its MTOM is from 101 to 170 tons;
- When User's aircraft carrying cargo by charter flights stays in the Airport for less than 9 (nine) hours and its MTOM is 171 tons and more.

Users whose aircraft land at the Airport as an alternate airport, shall pay 50 (fifty)% of the aircraft parking charge.

*MTOM – the maximum take-off weight*

4. Aircraft leading (follow me) charge – 51,87 Eur
5. The charge for the disabled persons and persons with reduced mobility – 0,11 Eur except for passengers travelling on direct transit flights and children under age of 2.

Charges are provided without VAT.
